Rules and policies:

1. Prices and Duties of Barefoot:

The prices and the duties of Barefoot are described in the offer of the booked tour. Changes are to be talked with the tour guide. Barefoot takes the right to change the program because of weather conditions or other unknown reasons which are involving the safety of the groups.

2. Your behavior:

a) Respect for the nature and the local people

b) It is essential that the instructions of the trip leader/ guide are followed at all times for the safety . Every member of the group is responsible that no other members of the group are disturbed by his behavior. We reserve the right to require any person to withdraw from the trip if their behavior is deemed offensive, dangerous or incompatible with the conduct of others, and we shall be under no further liability to any such person. The price will not be refunded.

3. Barefoot S.R.L. – Romania is not responsible for:

- a) The choosing of quitting before the end of a tour lead by Barefoot S.R.L. – Romania, will be made on your own responsibility, risk and without any refunding.
- b) The injuries of any kind provoked by yourself (or one of the persons in your care), to you or any other group member by not respecting the rules of the tour, will be your own responsibility, and you will be the person which suffers the consequences.
- c) The controlling of the nature, in any way.

4. Cancellation:

You have all the time the chance to quit the contract. In your interest you should do as written.

If you want to quit, you have to send us a letter, announcing that you quit, the names of the persons that quit the contract, (together with the telephone number to which each person will be contacted to confirm the cancellation), the account/accounts data to which the money will be returned and, eventually, the reason of quitting.

The day of quitting is considered the day we receive the letter.

- Until 45 days before starting of the tour it will cost you 10% of the hole costs. (Minimum 40,00€ for office tax).
- 44 to 21 days before starting - 50% of the hole price;
- Within less than 21 days before the starting day will cost you 100%.

5. Privacy:

Some of the services offered by us require us to share your personal data with the service providers we use to provide our services to you (for example, our accommodation partners will require certain elements of your private data for preparing the menu, or the bank will ask your account data in case of refunding). Otherwise, **NONE** of the data shared by you to Barefoot S.R.L. Romania will be shared to any third party!
